# 6. Delegations and Presentations

# 6.1 Saint John Police Website – Chief Robert Bruce / Staff Sergeant Sean Rocca

Chief Robert Bruce introduced Staff Sergeant Sean Rocca, Executive Officer, and Corporate Communications and he along with Lois Gorman, Manager of PSCC Operations & Information Systems and Jen Urquhart, Administrative Assistant / Support Services, were instrumental in putting this together for the public, with the introduction of Online Crime Reporting. The website focuses on community interaction with ease and accessibility of what the Saint John Police currently do.

Staff Sergeant Rocca gave a brief overview and mentioned that three initiatives touch on three separate strategic priorities that came out of the five-year strategic plan. One is improving their brand, which is the new website, two is focusing on talent development which is the recruiting video and their efforts on recruiting and the third is operational efficiency which is the Online Crime Reporting piece, and he went through a

sample process showing how that works. The new website is driven by the most common use services that citizens want from the Saint John Police and he went through the website service bars explaining all the information included <a href="www.saintjohnpolice.ca">www.saintjohnpolice.ca</a> He stated that it will soon be live and for the first time, they will have publicly posted the new SJPF recruitment video: <a href="Facebook">Facebook</a> or on the website <a href="Sworn Police Officers">Sworn Police Officers</a> | <a href="Saint John Police Force">Saint John Police Force</a>.

Staff Sergeant Rocca stated that was a pleasure to demonstrate the new website, along with the Online Crime Reporting and the launch of their new recruitment video.

Chief Bruce thanked all their members who helped make this project a success.

# 8.2 SJBPC Operating Budget / January 31, 2023

Frank Szalai, Senior Financial Manager reported that the Saint John Board of Police Commissioners (SJBPC) preliminary unaudited operating budget as of January 31, 2023, shows a surplus of \$583 year to date. Overall wages and benefits are under budget by \$22 and goods and services are under budget by \$561 year to date.

General services are under budget due to the timing related to the annual membership fee payments; thus, this favorable difference is temporary.

# 8.3 SJPF Operating Budget / January 31, 2023

Frank Szalai, Senior Financial Manager reported that the Force's preliminary unaudited January 31, 2023, operating budget results show a surplus of \$149,466 for the year. Overall wages and benefits are under budget by \$21,815 and can be largely attributed to vacancies. Goods and services are under budget by \$127,651 due to a variety of factors.

In January wage recoveries create favourable variances versus budget, the funds are provided by WorkSafe NB; some of that money is related to prior periods but all being recognized in the first months of 2023.

Fleet related favourable variances can be mostly contributed to timing differences. The purchases of vehicles (timing is largely dependent on the suppliers) is the largest contributor, the maintenance costs related to the vehicles is the lesser contributor. It is expected that costs related to both of those categories will be incurred at a later time during 2023.

Under general services, some of the favourable variances towards budget are related to supplier charges not yet received. These costs are expected to be incurred in the following period(s).

Unfavourable variances under Professional Services and Purchased Goods are one-time variances. Under Professional Services costs related to legal services were captured from 2022, and in Purchased Goods, the imprest funds related to multiple months, are recognized in January.

Revenue is anticipated to be on budget for 2023.

# 8.4 PSCC Operating Budget / January 31, 2023

The Public Safety Communication Centre's (PSCC's) Operating Budget as of January 31, 2023, shows a surplus of \$16,985 year to date.

Overall wages and benefits are under budget by \$12,230 and goods and services are underbudget by \$4,755 year to date.

Lack of employees are driving the surplus in wages and is a result of challenges related to recruitment; the favourable impact is temporary.

Revenue is anticipated to be on budget for year end.
