1. Call to Order

1.1 Remarks from the Chair

- 8.1 <u>Internal Monthly Report October 2023</u>

Chief Bruce reported that during the month of October there were three (3) complaints, six (6) complimentary correspondences and four (4) grievances.

8.2 SJBPC Operating Budget / September 30, 2023

Frank Szalai, Senior Financial Manager reported that the Police Commission's September 30, 2023, unaudited preliminary operating budget results show a surplus of \$26,225 year to date.

Overall wages and benefits are under budget by \$1,821 and goods and services are under budget by \$24,404 year to date. The wages and benefits are under budget due to mapping issues, and goods and services are under budget due to timing differences, the expectation is to receive costs against those budget items in the coming weeks / months and those expenses should be in line with the budgeted amounts.

8.3 SJPF Operating Budget / September 30, 2023

Frank Szalai, Senior Financial Manager reported that the Force's preliminary unaudited September 30, 2023, operating budget results shows a surplus of \$1,164,029 for the year.

Overall wages and benefits are under budget by \$904,201 and can be largely attributed to vacancies.

Goods and services are under budget by \$259,828 due to two primary components: 1) temporary timing-related variances. The net impact is \$109K, and 2) Realized cost savings, where the actual costs were lower than the budgeted amounts or where savings were not initially budgeted, amounting to net \$163K favourable.

Revenue for 2023 is projected to meet the budget. Mr. Szalai went through the timing and other differences that were mentioned in the submitted report.

8.4 PSCC Operating Budget / September 30, 2023

Frank Szalai, Senior Financial Manager reported that the Public Safety Communication Centre's (PSCC's) preliminary unaudited Operating Budget as of September 30, 2023, shows a surplus of \$139,797 year to date.

Overall wages and benefits are under budget by \$144,521 and goods and services are overbudget by \$4,725 year to date.

Differences on Salaries:

- 1. The reported favorable variance of \$144,521 in salaries is primarily due to a labour dispute that led local Union 486 employees to strike from September 12 to October 11. Wages and benefits were halted during this period, and the financial impact will extend into October.
- 2. As a result of the new agreement, the following wage increases will be implemented, all these impacting the 2023 fiscal year:

A one-time payment of \$750 was made to eligible employees in October.

A two per cent increase effective Jan. 1, 2022.

A two per cent increase effective July 1, 2022.

A two per cent increase effective Jan. 1, 2023.

A two per cent increase effective July 1, 2023.

3. The estimated impact of all these increases and resulting payments will offset the current favourability on salaries and wages and will push the department into the red. The city is finalizing the calculations related to the total cost of these changes, PSCC is expected to be overbudget by year end on wages and salaries. Once the figures are calculated the report will include this information.

Differences on Goods and Services:

- The most significant realized unfavorable variance in this category is tied to Purchased Goods/Other Goods, with a YTD figure of \$15,732. This was driven by the labor dispute, which necessitated additional hardware purchases to maintain service levels at the PSCC center (e.g., new headsets and communication equipment). Additionally, some software updates were expedited in anticipation of the strike to ensure uninterrupted service.
- 2. There are various other GL's where PSCC had realized savings related to spendings on Goods and Services, resulting in the overall unfavourability of \$4,725 year to date.

Revenue is anticipated to be on budget for year end.

8.6 <u>Saint John Police Foot Patrols</u>

Beginning in 2022, the Saint John Police Command Team and Community Engagement Team began proactively conducting foot patrols in our priority neighborhoods. The purpose was to enhance community engagement, to prevent and deter crime, and to develop a more in-depth understanding of the concerns facing these various communities in order to collectively engage in problem solving.

Saint John Police Foot Patrols are conducted during the spring, summer and fall months. In 2022, a total of 46-foot patrols were conducted. To date, in 2023, a total of 42-foot patrols have been conducted, twenty-two of which were focused in the Uptown and Waterloo Village neighbourhoods due to concerns raised about problematic activities in these areas.

8.7 <u>Senior Fraud Prevention Initiative</u>

The Saint John Police are Launching a series of fraud prevention sessions aimed at empowering the senior members of our community. This initiative is a direct response to the fraudulent activities targeting the elderly population, which is often the most vulnerable due to a lack of familiarity with digital platforms and the increasing sophistication of scams.

The initiative will consist of educational sessions designed to increase awareness about different types of prevalent fraud schemes such as phone, online, and mail scams. The sessions will provide practical strategies for recognizing, preventing, and reporting such fraudulent activities.

The sessions will be delivered in-person during the month of January 2024 by Saint John Police Neighbourhood Officers at Saint John Police Headquarters. We will also collaborate with local community centers to reach out to as many seniors as possible.

By investing in preventative measures, we can safeguard our community's most vulnerable members, reducing their victimization and the associated costs to the community and law enforcement. This program aligns with our commitment to public safety and community engagement, serving as a proactive measure in crime prevention.
